Special Note: No cattle sale next week. The next sale will be the Northeast Missouri Show-Me-Select Heifer sale on Saturday, June 1, and the next regular sale will be a replacement cow sale on Tuesday, June 4.

Compared to last week, lightweight steer calves weighing less than 500 lbs sold 15.00-25.00 higher, with 500-600 lbs steady, and steers over 600 lbs 5.00-10.00 lower. Feeder heifers traded firm to 10.00 higher with the most advance on the lighter weights. Demand was very good for calves and moderate on yearlings with a light to moderate supply. Supply included: 100% Feeder Cattle (56% Steers, 44% Heifers). Feeder cattle supply over 600 lbs was 48%.
