In the West, dry whey prices moved 1 cent lower on the bottom end of the range and were unchanged on the top end of the range. The mostly price series moved lower on both ends. Demand is steady domestically. Export demand is moderate. Cheese production is busy overall, making liquid whey widely available to be utilized by sweet whey, whey protein concentrate, and whey protein isolate manufacturers. Although market strength for the higher whey protein concentrates has drawn some liquid whey from sweet whey production, sweet whey manufacturers note steady or strong production schedules. Despite some stakeholders reporting lower stocks of dry whey from producers this year compared to the prior year, loads are generally available to meet needs throughout the region.
