The group also discussed updating the section in the PPM to incorporate a threshold for member participation, rather than leave it up to the NOSB Chair to determine what constitutes non-participation. A member suggested including benchmarks, which could result in censure or a self-resignation. Another member proposed a "letter of resignation" signed at the start of members' terms agreeing to certain duties and responsibilities. Members were uncertain as to how to enforce an agreement.

Recap Spring meeting

- A member asked about the format for oral public comments: How the decision is made to be completely virtual or hybrid, and by whom.
- A member added the feedback she heard about the timing of the meeting. It was beneficial that they reviewed it at the Spring meeting in more depth.
- Recap on Equity Commission (NL). The NOP provided information about how it is incorporating
 the work of the Equity Commission into various aspects of the NOSB's work. NL will draft a
 document for the June 13 PDS call. The PDS may add more calls.
