#### **COMMERCIAL ITEM DESCRIPTION**

#### LEAFY GREENS, PRE-CUT, READY-TO-EAT OR READY-TO-USE

#### The U.S. Department of Agriculture (USDA) has authorized the use of this Commercial Item Description (CID).

**1. SCOPE.** This CID covers ready-to-eat or ready-to-use pre-cut leafy greens (leafy greens), packed in commercially acceptable containers, suitable for use by Federal, State, local governments, and other interested parties. **Please note: This document does not guarantee purchase of this item by USDA.**<sup>1</sup>

#### 2. PURCHASER NOTES.

#### 2.1 Purchasers *must specify* the following:

- Type(s), style(s), chop size(s), shred or slice size(s), purpose(s), packaging and agricultural practice(s) (Sec. 3).
- When compliance with analytical requirements must be verified (Sec. 7.2).
- Manufacturer's/distributor's certification (Sec. 10.4) or USDA certification (Sec. 10.5).

#### 2.2 Purchasers *may specify* the following:

- Good Agricultural Practices (GAP) Audit (Sec. 10.1).
- Food Defense (Sec. 10.2) and Manufacturer's Quality Assurance (Sec. 10.3). Purchaser must specify 10.4 or 10.5. In addition, purchaser may specify 10.1 or one of the following combinations: 10.2 with 10.3.1, 10.2 with 10.3.2, 10.3 with 10.3.1, or 10.3 with 10.3.2.
- Packaging requirements other than commercial (Sec. 11).

**3.** CLASSIFICATION. The leafy greens must conform to the following list which must be specified in the solicitation, contract, or purchase order.

### 4. MANUFACTURER'S/DISTRIBUTOR'S NOTES. Manufacturer's/distributor's products must meet the requirements of the:

- Processing guidelines (Sec. 5).
- Salient characteristics (Sec. 6).
- Analytical requirements: as specified by the purchaser (Sec. 7).
- Manufacturer's/distributor's product assurance (Sec. 8).
- Regulatory requirements (Sec. 9).
- Quality assurance provisions: as specified by the purchaser (Sec. 10).
- Packaging requirements other than commercial: as specified by the purchaser (Sec. 11).

#### 5. PROCESSING GUIDELINES.

**5.1 Processing.** The leafy greens components must be harvested and handled in accordance with the Federal Food and Drug Administration's (FDA's) Draft Guidance for Industry: *Guide to Minimize Food Safety Hazards of Fresh-cut Produce*<sup>3</sup>, Food Safety Modernization Act (FSMA) Final Rule on Produce Safety<sup>4</sup> and *Current Good Manufacturing Practice, Hazard Analysis, and Risk-Based Preventive Controls for Human Food* (21 Code of Federal Regulations (CFR) Part 117).

**5.2 Food defense.** The leafy greens must be processed and transported in accordance with *Mitigation Strategies to Protect Food Against Intentional Adulteration* (21 CFR Part 121). This regulation identifies the kinds of preventive measures food manufacturers, processors, or handlers may take to minimize the risk that food under their control will be subject to tampering or other malicious, criminal, or terrorist actions. The implementation of enhanced food defense preventive measures provides for the security of a plant's production processes and includes the storage and transportation of pre-production raw materials, other ingredients, and post-production finished product.

**5.3 Organic ingredients.** When organic leafy greens are specified in the solicitation, contract, or purchase order, the leafy greens must be produced, handled, and labeled in accordance with the USDA organic regulations by an operation that is certified organic in accordance with the requirements of the National Organic Program (7 CFR Part 205). A Certificate of Organic

Production or Handling must be provided to verify that the product was processed and handled in accordance with the USDA organic regulations.

**5.4 Temperature.** The leafy greens must be kept under refrigeration to maintain quality. Unless otherwise recommended, preparation, storage, and delivery temperatures must be greater than  $0^{\circ}C$  ( $32^{\circ}F$ ) but not more than  $5^{\circ}C$  ( $41^{\circ}F$ ).

**5.5 Shelf life.** Once the leafy greens are packaged, the remaining shelf life must be at least 7 days when stored at  $5^{\circ}C$  (41°F).

#### 6. SALIENT CHARACTERISTICS.

#### 6.1 Definitions.

**6.1.1** <u>**Ready-to-Eat**</u>. Product is intended for consumption by the public and to be consumed directly from the container without washing or other preparation.

**6.1.2** <u>**Ready-to-Use**</u>. Product is intended for consumption by the public and to be consumed after additional processing such as but not limited to washing or cooking by the end user.

**6.1.3** <u>Leafy greens</u>. The term "leafy greens" includes iceberg lettuce, romaine lettuce, leaf lettuce, butter lettuce, baby leaf lettuce (i.e., immature lettuce or leafy greens), escarole, endive, spring mix, spinach, cabbage, kale, arugula, and chard. The term "leafy greens" does not include herbs such as cilantro or parsley.

**6.1.4** <u>**Cut leafy greens**</u>. Fresh leafy greens whose leaves have been cut, chopped, shredded, sliced, or torn.

**6.1.4.1** <u>Chopped leafy greens</u>. To be cut into squares or rectangles not smaller than 2.54 cm x 2.54 cm (1 in x 1 in) unless otherwise specified in the solicitation, contract, or purchase order.

**6.1.4.2** <u>Shredded or sliced leafy greens</u>. To be cut into long narrow strips not smaller than 0.318 cm (1/8 in) unless otherwise specified in the solicitation, contract, or purchase order.

**6.2 Labeling.** All ingredients must be declared by their common or usual name in descending order of predominance by weight (21 CFR §101.4) unless exempted by 21 CFR §101.100.

#### 6.3 Ingredients.

**6.3.1** <u>Leafy greens</u>. The leafy greens must consist of one or more types of leafy greens. Other ingredients may include, but are not limited to other vegetables, nuts, and dried fruit.

**6.3.2** <u>Additional processing ingredients</u>. When used, all additional ingredients must meet the standards specified in the Food Chemicals Codex (FCC) or, in the absence of FCC specification at a minimum, meet the specifications for quality set by the U.S. Pharmacopeia (USP)-National Formulary. The additional ingredients must be approved food additives (21 CFR Part 170) or meet Generally Recognized as Safe (GRAS) requirements (21 CFR Parts 182 and 184) for those uses by FDA.

#### 6.4 Finished product.

**6.4.1** <u>Color and odor</u>. The ingredients in the leafy greens must have a bright characteristic color. The leafy greens must be free from off odors such as, but not limited to, chlorine, ammonia, musty, moldy, sour, fermented smell, and other odors not typical of leafy greens.

**6.4.2** <u>Texture</u>. The leafy greens must be firm, fresh, and crisp, as typical for the type of leafy green, not wilted, flaccid, slimy, mushy, or tough.

**6.4.3** <u>Packaging</u>. The leafy greens can be packaged using MAP or vacuum packaging to retain quality. Packaging must not bloat to the extent that the bag is on the verge of rupturing or otherwise opening. Product package seals or seams must be free from any entrapped product and product must be free from excessive "free" liquid. Packaging must contain a code which allows traceability of the product in the event of a recall.

**6.5 Foreign material.** The leafy greens must be clean, sound, wholesome, and free from foreign material, such as, but not limited to, extraneous plant material, dirt, plastic, wood, metal, and evidence of insect or rodent infestation.

#### 7. ANALYTICAL REQUIREMENTS.

**7.1 Analytical and microbiological requirements.** Unless otherwise specified in the solicitation, contract or purchase order, the following analytical and microbiological requirements for the leafy greens must conform to those in Table I:

**7.2** Analytical verification. Purchaser must specify manufacturer's/distributor's certification (Sec. 10.4) or USDA certification (Sec. 10.5).

**7.3 USDA verification procedures.** When USDA certification (Sec. 10.5) is specified in the solicitation, contract, or purchase order, analytical testing must be performed as follows.

**7.3.1** <u>**Product verification sampling.**</u> When USDA verification of analytical requirements is specified in the solicitation, contract, or purchase order, analytical testing must be performed on subsamples of packages randomly selected from the lot. The number of subsamples must be based on USDA inspection service sampling procedures and plans (7 CFR §52.38). The contents of each will be used to create a composite sample that will be used in the analytical testing.

**7.3.2** <u>Analytical testing and reporting</u>. When specified in the solicitation, contract, or purchase order, the analyses must be made in accordance with the following methods from the Association of Official Analytical Collaboration (AOAC) International Official Methods of Analysis (OMA) or as specified in Table II. Any result not conforming to the analytical requirements may be cause for rejection of the lot.

**8. MANUFACTURER'S/DISTRIBUTOR'S PRODUCT ASSURANCE.** The manufacturer/ distributor must certify that the leafy greens provided meet the salient characteristics of this CID, conform to their own specifications, standards, and quality assurance practices, and be the same leafy greens offered for sale in the commercial market. The purchaser reserves the right to require proof of conformance.

**9. REGULATORY REQUIREMENTS.** The delivered leafy greens must comply with all applicable Federal, State, and local mandatory requirements and regulations relating to the preparation, packaging, labeling, storage, distribution, and sale of the leafy greens in the commercial marketplace. Delivered leafy greens must comply with all applicable provisions of the Federal Food, Drug, and Cosmetic (FD&C) Act, the Fair Packaging and Labeling Act, Food Allergen Labeling and Consumer Protection Act (FALCPA), and regulations promulgated thereunder. The allergen statement must be provided in a format which complies with FALCPA for any product which contains wheat, fish, milk, soy, tree nuts, eggs, peanuts, sesame, and Crustacean shellfish or those in effect on the date of the solicitation, contract, or purchase order. When the leafy greens are used for USDA, Child Nutrition Programs, the leafy greens must comply with all applicable provisions of those programs.

**10. QUALITY ASSURANCE PROVISIONS.** *Purchaser must specify 10.4 or 10.5. In addition, purchaser may specify 10.1 or one of the following combinations: 10.2 with 10.3.1, 10.2 with 10.3.2, 10.3 with 10.3.1, or 10.3 with 10.3.2.* 

**10.1 Good Agricultural Practices (GAP) audit verification program.** When required in the solicitation, contract, or purchase order, a GAP audit must be conducted by USDA, Agricultural Marketing Service (AMS), Specialty Crops Program (SCP), Specialty Crops Inspection (SCI) Division. A GAP audit must be performed at the site where the leafy greens are grown and at the packing house where the leafy greens are packed. The audit program consists of one initial audit, and at least one unannounced audit depending on how long the facility is in operation during a growing season. The purpose of the GAP audit verification program is to demonstrate that the participating company is adhering to generally recognized GAP principles.

**10.2 Food defense.** When required in the solicitation, contract, or purchase order, a Food Defense Systems Survey (FDSS) or audit must be conducted by USDA, AMS, SCP, SCI Division. Food defense requirements include a documented and operational food defense plan that provides for the security of a plant's production processes and includes the storage and transportation of pre-production raw materials and other ingredients and post-production finished product. The plan must address the following areas: (1) food security plan management; (2) outside and inside security of the production and storage facilities; (3) processing, including all raw material sources; (4) shipping and receiving; (5) storage; (6) water and ice supply; (7) mail handling; (8) personnel security; and (9) transportation, shipping, and receiving.

**10.2.1** <u>FDSS</u>. When required in the solicitation, contract, or purchase order, a FDSS must be conducted by USDA, AMS, SCP, SCI Division. The FDSS verifies that operators of food establishments have implemented measures to minimize the risk of tampering or other criminal actions against the food under their control. An AMS FDSS verifies the participating company's adherence to *Mitigation Strategies to Protect Food Against Intentional Adulteration* (21 CFR Part 121).

**10.2.2** <u>Food defense section of the Plant Systems Audit (PSA)</u>. When required in the solicitation, contract, or purchase order, a food defense audit will be conducted as part of the PSA. The audit will be conducted by USDA, AMS, SCP, SCI Division auditors. This verifies that operators of food establishments have implemented measures to minimize the risk of tampering or other criminal actions against the food under their control. The food defense section of the PSA verifies the participating company's adherence to *Mitigation Strategies to Protect Food Against Intentional Adulteration* (21 CFR Part 121).

**10.3 Manufacturer's quality assurance.** When required in the solicitation, contract, or purchase order, the product manufacturer will be required to provide evidence, by certificate that the manufacturing plant has undertaken one of the following quality assurance measures within 12 months prior to providing a bid or no later than 10 business days from the date of the

awarding of the contract. Failure to provide this documentation within the proper time frame may result in the contract being terminated for cause.

**10.3.1** <u>**Plant survey**</u>. A plant survey conducted by USDA, AMS, SCP, SCI Division is required within 12 months prior to the date of the awarding of the contract. The plant survey audit verifies that, at the time of the survey, the manufacturer produces products in a clean, sanitary environment in accordance with *Current Good Manufacturing Practice, Hazard Analysis, and Risk-Based Preventive Controls for Human Food* (21 CFR Part 117).

**10.3.2** <u>PSA</u>. A PSA conducted by USDA, AMS, SCP, SCI Division is required within 12 months prior to the date of the awarding of the contract. The PSA verifies the manufacturer's capability to produce products in a clean, sanitary environment in accordance with *Current Good Manufacturing Practice, Hazard Analysis, and Risk-Based Preventive Controls for Human Food* (21 CFR Part 117) and verifies that the manufacturer has in place an internal quality assurance program that meets or exceeds USDA requirements.

**10.4 Manufacturer's/distributor's certification.** When required in the solicitation, contract, or purchase order, the manufacturer/distributor must certify that the leafy greens delivered meet or exceed the requirements of this CID. The manufacturer/distributor must certify via a Certificate of Conformance or other adequate documentation (as specified by the purchaser) that the leafy greens meet analytical requirements specified in Sec. 7 of this CID.

**10.5 USDA certification.** When required in the solicitation, contract, or purchase order that product quality and acceptability or both be determined, the USDA, AMS, SCP, SCI Division inspectors, must be the certifying program. SCI Division inspectors must certify the quality and acceptability of the leafy greens in accordance with SCI Division procedures, which include selecting random samples of the leafy greens, evaluating the samples for conformance with the salient characteristics and analytical requirements of this CID and other contractual requirements, and documenting the findings on official SCI Division score sheets and/or certificates. In addition, when required in the solicitation, contract, or purchase order, SCI Division inspectors will examine the leafy greens for conformance to the *Standards for Condition of Food Containers* (7 CFR Part 42) in effect on the date of the solicitation.

**11. PACKAGING.** Preservation, packaging, packing, labeling, and case marking must be commercial unless otherwise specified in the solicitation, contract, or purchase order.

# 12. USDA INSPECTION NOTES. When Sec. 10.5 is specified in the solicitation, contract, or purchase order, USDA certification must include evaluation of the quality and condition of samples of leafy greens and compliance with requirements in the following areas:

- Processing guidelines (Sec. 5).
- Salient characteristics (Sec. 6).

- Analytical requirements *when specified in the solicitation, contract, or purchase order* (Sec. 7). When USDA analytical testing is specified, SCI Division inspection personnel must select samples and submit them to the USDA, AMS, Science and Technology Program (S&T) laboratory for analysis.
- Packaging requirements (Sec. 11).
