15 bales from June 2019, 81 bales from July 2019, 2,996 bales from August 2019, 17,630 bales September 2019, 24,633 bales from October 2019, 7,325 bales from November 2019, 12,066 bales from December 2019, 2,234 bales from January 2020, 58 bales from February 2020; 4,330 bales from March 2020; 2 bales from April 2020; 1,274 bales from June maturing loans.

Following were multiple invitations that sold 8,264 bales in September; 39,325 bales in November, 7,899 bales in December; 9,697 bales sold in January; 1,513 bales in February; 3,856 bales in March; 822 bales in April; 1,274 bales in July.

In total, there were 0 bales of upland cotton in inventory on July 31, 2020.

CCC also acquired 2018 Crop Year peanuts as follows: 4,559.12 tons from July 2019, 37,417.73 tons from August 2019, 37,845.19 tons from September 2019, 4,735.16 tons from October, 4,054.36 tons from November, and December 2,025.31 tons maturing loans.

Total CCC peanut forfeitures for Crop Year 2018 were 84,719.20 tons. CCC sold 340.51 tons from Invitation No. 8, 28,563.44 tons from Invitation No. 9, 13,052.09 tons from Invitation No. 10, 34,005.36 tons from Invitation No. 11, 3,846.40 tons from Invitation No.12, 4,268.73 tons from Invitation No. 13, 0 tons from Invitation 14, 2,780.41 from Invitation 15, 1,249.44 tons from Invitation 16, 667.18 tons from Invitation 17, 2025.31 tons from Invitation 19.

This brought the total CCC peanut inventory to 0.00 tons as of July 31, 2020.
