## SECTION 32 PURCHASE SPECIFICATION for FRESH TOMATOES Commodity Specification for Fresh Vegetables May 2019

### Prerequisites

Vendors or subcontractors who are supplying fresh tomatoes to the United States Department of Agriculture (USDA) through this Section 32 purchase must ensure that each of their suppliers/ subcontractors who grow, harvest, pack, hold, and handle product have currently approved food safety verification audits PRIOR to the bid opening date of the solicitation.

Specialty Crops Inspection Division (SCI) in-person or SCI approved third-party "desk audits" will be permitted for this purchase. ### **United States (U.S.) Product Origin**

All fresh tomatoes for this purchase must be of 100% domestic origin. When requested, the vendors must make all paperwork available to SCI that confirms 100% domestic origin traceback from the recipient destination to the origin physical growing location, including all steps in the process and a narrative of those steps.

#### **Inspection and Certification**

For this solicitation, inspection and certification of the fresh tomatoes will be performed at shipping point, during or after the final packaging, but prior to shipping. Inspection must be performed by SCI Federal or Federal-State Inspection Service only. Inspections under the Partners in Quality (PIQ) and Customer Assisted Inspection Program (CAIP) programs are not permitted or accepted for USDA Commodity Procurement purchases. The contractor must contact and allow the USDA Inspector at least 72 hours advance notice when scheduling inspection service. All fresh tomato deliveries must be "Positive Lot Identified" (PLI) in accordance with official SCI PLI methods.

The fresh tomatoes must reach destination within 5 calendar days of the inspection/certification, with day one being the inspection/certification date. When needed, adherence to this requirement will be determined by reviewing the required labeled packing date and the shipping and receiving documents. If SCI inspection/certification at shipping point/origin meets all requirements of this specification and solicitation, it does not guarantee acceptance at destination. Product at destination must still meet all applicable shipping point specification and solicitation requirements with no additional tolerances allowed. Failure to meet these requirements may result in rejection of the load at destination. It is the vendor's responsibility to

ensure the delivery of acceptable product and replacement of any failed deliveries with acceptable product.

The fresh tomatoes must also meet all relevant requirements of the Commodity Specification for Fresh Vegetables, May 2019, and the below additional individual commodity specification requirements.

# **Individual Commodity Specification for Section 32 Purchase of Fresh Tomatoes**

Grade: U.S. Combination Grade, with at least 85% U.S. No. 1 Quality

<u>Color:</u> A minimum of 80% of the tomatoes in the lot must be either "Turning" or "Pink". As defined by the United States Standards for Grades of Fresh Tomatoes <u>https://www.ams.usda.gov/sites/default/files/media/Tomato\_Standard%5B1%5D.pdf</u>

Size: The tomatoes must be 5x6 (Florida size), or in instances where the tomatoes were not packed to an "official" Florida size, a minimum diameter of 2 and 25/32 inches will be accepted.

**<u>Type</u>:** Fresh field grown round red tomatoes only are permitted. Cherry, Grape, Roma, Plum or Pear type, tomatoes on the vine, Heirloom or other similar types or Greenhouse tomatoes are not part of this purchase and are not permitted.

**Type of Pack: 25-pound cartons.** 

Labeling: Must be labeled with the minimum FDA and industry labeling requirements and must include the date of pack. Each 25 lb. carton must also show the grower and shipper name and address and whether it be Florida size 5x6 or the minimum diameter requirement, those sizes must be stated on the carton/cover/pallet tag.

<u>Transportation</u>: Must be transported to destination in a refrigerated trailer at an ambient air temperature of plus (above zero degrees Fahrenheit (F)) 41 to 46 degrees F. Failure to meet this requirement at destination may be cause for rejection.

**Quantity per Truckload** 1,600 - 25-pound cartons per truckload.
