USDA BUYS: CANNED BONED POULTRY

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 1,096,000 pounds of canned boned poultry at an approximate delivered cost of \$1,888,000 for school lunch and domestic food nutrition assistance programs. Details of today's purchase follow:
