The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 1,724,000 pounds of turkey and turkey products at a cost of approximately \$2,196,000 for school lunch and other domestic food nutrition assistance programs. Details of today's purchase follow:
