PURCHASE AND OFFER TO BUY: DELI-STYLE TURKEY BREAST AND
SMOKED TURKEY BREAST; PURCHASES

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 1,240,000 pounds of deli-style turkey breast at a cost of approximately \$2,049,000 for school lunch and other domestic food nutrition assistance programs. Details of today's purchases follow:
