USDA BUYS: CANNED WHITE TURKEY MEAT

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 110,000 pounds of canned white turkey meat at an approximate delivered cost of \$260,000 for domestic food nutrition assistance programs. Details of today's purchase follow:
