PURCHASE AND OFFER TO BUY: Commercial Pack Geese; Purchases

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 312,000 pounds of frozen geese at a cost of approximately \$515,000 for domestic food nutrition assistance programs. Details of today's purchase follow:
