

Official Listing of Approved Sources of Non-Hormone Treated Cattle

All farms, ranches, and feedlots who raise beef destined for shipment to the European Union (EU) as non-hormone treated cattle must be audited, approved and listed on this website in order to be eligible for export certification from FSIS.

All cattle management groups who approve farms, ranches, and feedlots who raise beef destined for shipment to the EU as NHTC cattle must be audited, approved and listed on this website. Farms, ranches, and feedlots approved by cattle management groups are eligible for export certification from FSIS. Each cattle management group's list of approved farms, ranches, and feedlots is available on the FSIS Partner Web.

The farms, ranches, feedlots, and cattle management groups listed below have been audited by the Livestock and Seed Program, ARC Branch; and are approved sources of non-hormone treated cattle and are eligible for further evaluation by FSIS.

Approved slaughter facilities are listed on the FSIS list of slaughter and processing facilities approved for export to the EU.
