CHICKEN FAJITA STRIPS, INVITATION NO. 8, ANNOUNCEMENT PY-310

The U.S. Department of Agriculture invites offers to sell chicken fajita strips as indicated below and per the Announcement for use in school lunch and other domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Oct. 23. Acceptances will be announced by midnight, Friday, Oct. 27. Deliveries are to be made from Dec. 1 to Dec. 15.

All offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted by any means other than DEBES will be considered nonresponsive.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Items listed as "KOSHER ONLY" must be produced as a Kosher product. Shipping instructions will indicate quantity to be delivered to each point.
