CANNED BONED POULTRY, INVITATION NO. 26, ANNOUNCEMENT PY-290

The U.S. Department of Agriculture invites offers to sell canned boned poultry as indicated below and per the Announcement for domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Nov. 20. Acceptances will be announced by midnight, Friday, Nov. 24. Deliveries are to be made from Jan. 1 to Mar. 31, 2007.

Offers will be invited from the trade for canned boned poultry in 29-ounce (822 g) cans, packed 24 cans to a shipping container with 43.5 pounds (19.73 kg) net weight in purchase units of 36,540 pounds (16,574 kg) net weight.

All offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted by any means other than DEBES will be considered nonresponsive.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.
