**CANNED BONED POULTRY, INVITATION NO. 27, ANNOUNCEMENT PY-290; FINAL REQUIREMENTS FOR CANNED BONED POULTRY IN 50-OUNCE CANS**

The U.S. Department of Agriculture invites offers to sell canned boned poultry as indicated below and per the Announcement for domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Nov. 27. Acceptances will be announced by midnight, Friday, Dec. 1. Deliveries are to be made from Jan. 16 to Jan. 31, 2007. **Purchase of the quantities listed on this invitation will complete current requirements for canned boned poultry in 50-ounce cans.**

Offers will be invited from the trade for canned boned poultry in 50-ounce (1.42 kg) cans, packed 12 cans to a shipping container. A purchase unit will consist of 1,000 shipping containers totaling 37,500 pounds (17,010 kg).

All offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted by any means other than DEBES will be considered nonresponsive.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.
