All prime vendors are reminded that they are prohibited from subcontracting with companies or individuals that have been suspended or debarred.

**All invitations with orders for the state of New York, must have the pack date stamped on the outside of each carton. The pack date should be annotated as per the following example: (05/01/2003). Orders for the state of New York requiring the special marking will be indicated by (\*\*). This applies to New York orders "Only," if and when they appear on an invitation.**

**Note:** Effective August 1, 2005, Contractors are required to submit Annual Representations and Certifications via the Online Representation and Certifications Application (ORCA), a part of Business Partner Network (BPN). The internet address for registering in ORCA is <http://orca.bpn.gov>. The representations and certifications are effective until one year from the date of submission or update to ORCA. A revised abbreviated Appendix 1 dated August 2005 will be required for contractors registering via the ORCA system. However, Contractors who have previously (prior to August 1, 2005) submitted the Appendix 1 for calendar year 2005 will be relieved from the ORCA online registration until the expiration of their Appendix 1.



**Bids must be submitted electronically via the Domestic Electronic Bid Entry System (DEBES) on the Internet. Offerors who submit bids using other than DEBES, will be deemed non-responsive.** Offeror must be assigned a Logon ID by USDA to access the site. 
