USDA SETS HEARING ON PROPOSED AMENDMENTS TO ALL FEDERAL MILK ORDERS

Washington, D.C., Feb. 7, 2007 – The U. S. Department of Agriculture today announced that it will hold a national public hearing to consider proposals seeking to amend the Class III and Class IV product price formulas applicable to all Federal milk marketing orders. The hearing will begin at 9:00 a.m. on Feb. 26, 2007, at the Holiday Inn Select - Strongsville, 15471 Royalton Road, Strongsville, Ohio 44136.

USDA requested proposals from the industry that would examine all features of the Class III and Class IV product price formulas. Both producer cooperatives and milk product manufacturers submitted proposals.

The hearing notice will be published in the Feb. 9 Federal Register. 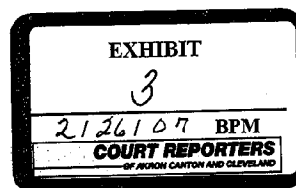

USDA PUBLISHES SUPPLEMENT TO NOTICE OF FEB. 26 PUBLIC HEARING

Washington, D.C., Feb. 16, 2007 – The U.S. Department of Agriculture today announced a supplement to the notice of public hearing issued on Feb. 7, 2007, to consider proposals seeking to amend the Class III and Class IV product price formulas applicable to all Federal milk marketing orders.

An additional proposal, which seeks to establish cost-of-production surcharges that manufacturers could include in the selling price of their products but would not be included in the determination of NASS survey prices for cheese, butter, nonfat dry milk and dry whey, will be considered at the hearing.

The hearing will begin at 9:00 a.m. on Feb. 26, 2007, at the Holiday Inn Select – Strongsville, 15471 Royalton Road, Strongsville, Ohio 44136.
