BUYS: Canned Vegetables

The Department of Agriculture (USDA) purchased canned tomato products for use in child nutrition and other domestic food assistance programs for Fiscal Year 2007.

Products, quantities, size of pack, and program costs consist of the following:

USDA has rejected offers submitted in response to Announcement FV-302, Inv. 076, Tomato Paste in Bulk, dated September 26, 2006. Offers were rejected due to lack of competitive bids received.
