**FROZEN BONELESS PORK LEG ROASTS and PICNICS, ANNOUNCEMENT  
LS-122, AS AMENDED, INVITATION 026:**

The U.S. Department of Agriculture (USDA) invites offers pursuant to ANNOUNCEMENT LS-122 to sell frozen boneless pork leg roasts and picnics for further processing into cooked products to be distributed in Federal food and nutrition programs. Purchases will be made on an f.o.b. destination basis to cities indicated below. Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.

**In order to submit offers on this Invitation, Offerors must be deemed eligible by the Contracting Officer.**

All offers must be in the format prescribed in LS-122 and be submitted electronically via the internet. Offers must be received by **1:30 p.m., CENTRAL TIME, Friday, July 20, 2007**. Acceptances will be announced by midnight, **Friday, July 27, 2007**. Shipment will be made between **September 1-15, 2007**.

**State-inspected plants that are operating under the State-Federal Cooperative Agreement, Section 301 of the Federal Meat Inspection Act, will not be allowed to bid on the boneless picnics since this product will be crossing State lines. Only state-inspected plants producing the boneless pork leg roasts will be allowed to bid on destinations within their State, except for those marked "Federal Plants Only."**
