OFFER TO BUY: Canned, Frozen and Dried Fruit and Canned and Frozen Vegetables

The Department of Agriculture announced it is planning to purchase canned, frozen and dried fruit and canned and frozen vegetables for donation to the Child Nutrition Program in fiscal year 2008, according to Robert C. Keeney, Deputy Administrator, Fruit and Vegetable Programs, Agricultural Marketing Service.

The anticipated purchases will be made from offers that must be submitted on a delivered-to-destination price basis. Deliveries will be required during the period of November 30, 2007 through April 30, 2008.
