BUYS: Purchase of Canned Juices

The Department of Agriculture (USDA) purchased Canned Juices for distribution to Needy Family and other related domestic food assistance programs for fiscal year 2008.

Product, quantity, pounds and program cost consist of the following:

Product/Pack Size	No. of Cases	Pounds	Total Cost
Grape Juice, 12/46 oz. can	28,560	1,085,280	\$463,624.00
Grapefruit Juice, 12/46 oz. can	4,760	176,120	\$57,643.60

The purchase is the result of offers received in response to USDA's purchase Announcement FV305, Invitation 062 of December 13, 2007. The products were purchased on a delivered-to-destination basis. Deliveries are to be made from February 1, 2008 to February 29, 2008.

Unawarded: A total of 24,752 cases of juice were not bought for the following reasons: The Food and Nutrition Services Division cancelled 6,664 cases of grape juice and 3,808 cases of grapefruit juice were not purchased due to price consideration.

A total of 14,280 cases of cranberry/apple juice were not purchased due to price considerations.
