The U.S. Department of Agriculture (USDA) invites offers pursuant to ANNOUNCEMENT LS-123, as amended, to sell frozen, cooked beef and pork products to be distributed in Federal food and nutrition programs. Purchases will be made on an f.o.b. destination basis to cities indicated below. Destination quantities listed are estimates and subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.

In order to submit offers on this Invitation, Offerors must be deemed eligible by the Contracting Officer.

All offers must be in the format prescribed in LS-123, as amended, and be received by **1:00 p.m., CENTRAL TIME, Friday, November 9, 2007**. Acceptances will be announced by midnight, **Friday, November 16, 2007**. Shipments must be made in two periods between **January 1 and January 31, 2008**.
