

FEDERAL MILK ORDER MARKETING AND UTILIZATION SUMMARY, MARCH

HIGHLIGHTS. Handler reports of receipts and utilization under the Federal milk order system for March have been filed and tabulated. Combined totals for the 10 consolidated orders are being released. During March, about 9.4 billion pounds of milk were received from producers. This volume of milk is 5.2 percent lower than the March 2007 volume. In March 2007 and March 2008, there were significant volumes of milk not pooled due to intraorder disadvantageous price relationships. About 3.8 billion pounds of producer milk were used in Class I products, 4.6 percent lower than the previous year. The timing of the Easter season, as well as calendar composition, likely had a negative impact on milk used in Class I in 2008 as compared to 2007. The all-market average Class utilization percentages were; Class I = 41%, Class II = 13%, Class III = 30%, and Class IV = 16%. The weighted average statistical uniform price was \$17.64 per cwt., \$1.20 lower than last month and \$2.03 higher than last year.

3/ Due to a disadvantageous relationship between intraorder class prices and the location adjusted statistical uniform (blend) price in these markets, handlers elected not to pool an estimated 1.6 billion pounds of milk that normally would have been associated with these markets. In March 2007, the estimated not pooled volume of milk was 900 million pounds, occurring in Order Nos. 033, 030, and 032. After adjusting for not-pooled milk, the year-to-year percent change is +2.1%.
