PORK PATTIES, FULLY-COOKED, SUPPLEMENT LS-400 TO AMS MASTER SOLICITATION, INVITATION NO. 901:

The U.S. Department of Agriculture invites offers pursuant to Supplement LS-400 to AMS Master Solicitation to sell fully cooked, pork patties, for use in Federal food and nutrition programs. The pork patties are to be delivered in a frozen state. Purchases will be made on a shipping basis to destinations indicated herein. The product must be shipped to the destinations within the shipping period. Destination quantities are estimates and are subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.

All offers must be in the format prescribed in LS-400 and be received by **1:00 p.m., CENTRAL TIME, Tuesday, July 22 2008**. Acceptances will be announced by midnight **Friday, July 25, 2008**. Shipments will be made between **September 16 and September 30, 2008**.

In order to submit offers on this Invitation, offerors must be deemed eligible by the Contracting Officer. Product purchased under this Invitation will be produced according to the Item Description and Checklist of Requirements for Pork Patties, Fully Cooked, dated May 2008 and eligible suppliers approved production plan.

Bids must be submitted electronically via the internet. Offerors must be assigned a Logon ID by USDA to access the site. 
