

**FEDERAL MILK ORDER MARKETING AND UTILIZATION SUMMARY, JUNE**

**HIGHLIGHTS.** Handler reports of receipts and utilization under the Federal milk order system for June have been filed and tabulated. Combined totals for the 10 consolidated orders are being released. During June, about 8.5 billion pounds of milk were received from producers. This volume of milk is 0.7 percent lower than the June 2007 volume. In June 2007 and June 2008, there were significant volumes of milk not pooled due to intraorder disadvantageous price relationships. About 3.4 billion pounds of producer milk were used in Class I products, 4.0 percent lower than the previous year. The all-market average Class utilization percentages were; Class I = 40%, Class II = 15%, Class III = 28%, and Class IV = 17%. The weighted average statistical uniform price was \$19.45 per cwt., \$1.40 higher than last month and \$0.90 lower than last year.

3/ Due to a disadvantageous relationship between intraorder class prices and the location adjusted statistical uniform (blend) price in these markets, handlers elected not to pool an estimated 1.9 billion pounds of milk that normally would have been associated with these markets. In June 2007, the estimated not pooled volume of milk was 1.8 billion pounds, occurring in Order Nos. 001, 005, 007, 033, 030, 032, 126, and 124. After adjusting for not-pooled milk, the year-to-year percent change is +0.9%.
