The U.S. Department of Agriculture (USDA) invites offers pursuant to ANNOUNCEMENT LS-130, as amended, to sell frozen lamb products for use in Federal food and nutrition programs. Purchases will be made on a shipping period basis to destinations indicated below. Destination quantities listed are estimates and are subject to adjustment based on offerings, changes in recipient needs, market conditions, and program operations.

Product purchased under this Invitation will be produced in accordance with Announcement LS-130, as amended; Errata Page to Amendment 1, dated August 2007; Amendment 1 to Announcement LS-130, dated July 2007; and Exhibit A, dated July 2007 and as specified for each product type.

All offers for Type 5 and Type 6 lamb products must be in the format prescribed in LS-130, as amended, and received by 1:30 p.m., CENTRAL TIME, Monday, September 8, 2008. Acceptances will be announced by, midnight, Friday, September 12, 2008. Shipments are to be made in two periods between October 16, 2008, and November 15, 2008.

State-inspected plants that are operating under the State-Federal Cooperative Agreement, Section 301 of the Federal Meat Inspection Act, may bid on destinations within their State except for those items marked FEDERAL PLANTS ONLY.

Bids MUST BE submitted electronically via the internet. Offerors must be assigned a Logon ID by USDA to access the site.
