PURCHASE AND OFFER TO BUY: CHICKEN CRUMBLES AND BURGER-STYLE PATTIES; PURCHASES NEARING END

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 702,000 pounds of chicken crumbles and burger-style patties at a cost of approximately \$1,113,000 for school lunch and other domestic food nutrition assistance programs. Details of today's purchase follow:
