PURCHASE AND OFFER TO BUY: CHICKEN FAJITA STRIPS; ENDS PROGRAM

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 351,000 pounds of chicken fajita strips at a cost of approximately \$637,000 for school lunch and other domestic food nutrition assistance programs. Details of today's purchase follow:
