USDA BUYS: CONSUMER PACK CUT-UP CHICKEN

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 499,000 pounds of consumer pack cut-up chickens at an approximate cost of \$446,000 for domestic food nutrition assistance programs. Details of today's purchase follow:
