PURCHASE AND OFFER TO BUY: CHICKEN AND CHICKEN PRODUCTS

The U.S. Department of Agriculture's Agricultural Marketing Service (AMS) today purchased 7,212,000 pounds of chicken and chicken products at an approximate cost of \$5,303,000 for school lunch and other domestic food nutrition assistance programs. Details of today's purchase follow:
