CHICKEN BURGERS, INVITATION NO. 1, ANNOUNCEMENT PY-328

The U.S. Department of Agriculture invites offers to sell frozen chicken burgers as indicated below and per the Announcement for use in school lunch and other domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, **Wednesday, Oct. 31**. Acceptances will be announced by midnight, Friday, Nov. 2. Deliveries are to be made from Nov. 16 to Nov. 30.

Interested offerors may contact this office on 202/720-7693 to schedule delivery of pre-bid samples. Vendors whose samples pass the evaluation process will be approved to provide offers.

Offers are invited from suppliers which have been approved by the Contracting Officer for frozen fully cooked chicken (fowl) burgers, produced from ground and seasoned fowl, formed into burgers weighing 2.5 ounces (71 g). The commodity must be packaged in 5-pound bags (4.54-kg) or bulk packaged in a bag to a net weight of 30 pounds (13.61 kg) in each fiberboard shipping container. A purchase unit will consist of 1,300 shipping containers totaling 39,000 pounds (17,690 kg).

All offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted by any means other than DEBES will be considered nonresponsive.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.

Delivery by mechanically refrigerated trucks or railcars is optional to the contractor, except for those destination(s) which specify delivery by truck only or rail only.
