CONSUMER PACK CHICKENS, INVITATION NO. 12, ANNOUNCEMENT PY-318

The U.S. Department of Agriculture invites offers to sell frozen consumer pack chickens as indicated below and per the Announcement for domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Tuesday, Feb. 19 (due to the holiday on Monday for Federal employees). Acceptances will be announced by midnight, Friday, Feb. 22. Deliveries are to be made from April 1 to June 30.

Offers are invited from the trade for frozen U.S. Grade A ready-to-cook young chickens, with neck and giblets. Individual chickens must weigh 3 to 4.25 pounds (1.36 to 1.93 kg) per carcass weighed without neck and giblets. The commodity must be commercially labeled and packed in individual plastic-film bags with 10-12 chickens per fiberboard shipping container. A purchase unit will total 39,600 pounds (17,962 kg).

All offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted by any means other than DEBES will be considered nonresponsive.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.

Destination quantities are estimates and are subject to adjustment based on offerings, changes in recipient need, market conditions, and program operations. Delivery by mechanically refrigerated trucks or railcars is optional to the contractor, except for those destination(s) which specify delivery by truck only or rail only.


