The U.S. Department of Agriculture invites offers to sell all purpose egg mix as indicated below and per the Master Solicitation for use in school lunch and other domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Aug. 18. Acceptances will be announced by midnight, Friday, Aug. 22. Deliveries are to be made from Oct. 1 to Dec. 15.
