CHICKEN AND CHICKEN PRODUCTS PY-332, INVITATION NO. 909

The U.S. Department of Agriculture invites offers to sell chicken and chicken products as indicated below and per the Master Solicitation for use in school lunch and other domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Oct. 6. Acceptances will be announced by midnight, Friday, Oct. 10. Deliveries are to be made from Nov. 1 to Nov. 15.

All offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbcl000.exe?>. Offers submitted by any means other than DEBES will be considered nonresponsive.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. **Note that some item numbers and associated quantities for cooked batter/breaded chicken have been set-aside for service-disabled veteran-owned businesses and are indicated by a double asterisk.** Items listed as "KOSHER ONLY" must be produced as a kosher product. Shipping instructions will indicate quantity to be delivered to each point.

Purchases of the commodities listed below will be made on a delivered basis, subject to The Master Solicitation dated May 2008, to the listed locations. Destination quantities are estimates and are subject to adjustment based on offerings, changes in recipient need, market conditions, and program operations. Delivery by mechanically refrigerated trucks or railcars is optional to the contractor, except for those destination(s) which specify delivery by truck only or rail only.

Bulk Pack, Large (222590) - Bulk packed for further processing, chilled ready-to-cook broiler/fryer chickens without necks or giblets. Frozen may be specified in this Invitation. The individual chicken weight range must be over 3.75 pounds (over 1.70 kg) per carcass weighed without neck and giblets. The commodity must be packed in commercial containers as required within the Commodity Specification for Bulk Pack Chicken and Chicken Parts dated May 2008. A purchase unit will total 36,000 pounds (16,329 kg).

Chicken Legs, Bulk Parts (224190) - Chilled chicken legs, bulk packed for further processing. Legs must weigh between 5 and 17.50 ounces (141.75 and 496.11 g) each, or be produced from ready-to-cook broiler/fryer chickens which weigh 2.50 to 7 pounds (1.13 to 3.18 kg) per whole carcass, without neck and giblets. Frozen may be specified in this Invitation. The commodity must be packed in commercial containers as required within the Commodity Specification for Bulk Pack Chicken and Chicken Parts dated May 2008. A purchase unit will total 36,000 pounds (16,329 kg).
