EXHIBIT A

Origin and Breeding History of the Variety

1. Domingos 43 was an individual plant selection from the variety Vanguard. This selection was made in the San Joaquin Valley of California in 1972.
2. Initial trial plantings were conducted in the Fall of 1972 for evaluation and reselection.

A number of subsequent trials followed to allow for more comprehensive evaluations and further selection work. Selections were made on the basis of size, color, texture and heading tendencies. Trials were conducted in Yuma, Arizona and the San Joaquin Valley of California.

3. Domingos 43 is genetically uniform and free of any distinct variations.

Annual. A crisphead variety with a large sized frame. Wrapper leaves are similar in texture and color to Vanguard but are larger.

Head is spherical. Butt of plant is medium smooth with a medium green color. Diameter of the core is large. Petioles medium smooth. Adapted for the early April harvest period in the San Joaquin Valley of California. This variety will produce a head size of 5½" to 6" in diameter during this period.

Seedstalk is medium height, very uniform. Produces a large sized panicle and is a heavy seed yielder. Seed color is black.

EXHIBIT D: Data Indications of Novelty

Domingos 43 most closely resembles the variety Vanguard. It was developed to replace the variety Climax for early spring harvest in the San Joaquin Valley of California.

Its distinguishing features include:

1. Unique in that it will produce a larger plant than Vanguard for early spring harvest in the San Joaquin Valley of California. Domingos 43 will produce under normal conditions an average head size of 5½" to 6" in diameter. Vanguard head size under the same conditions will be somewhat smaller. Domingos 43 will produce a slightly larger frame in this same period averaging 19" in diameter, while Vanguard will average approximately 17".
2. Domingos 43 will mature approximately three days earlier than the variety Climax.




