Orders for the state of New York requiring the special marking will be indicated by (\*\*). This applies to New York orders "Only," if and when they appear on an invitation.**

**Vendors doing business with USDA are required to be registered in the Central Contractor Registration (CCR) system before being awarded contracts. If the Offeror is not registered in the CCR database at the time of bid opening, offers will be deemed non-responsive.**
