CANNED BONED POULTRY, INVITATION NO. 033, ANNOUNCEMENT PY-225, AS AMENDED

The U.S. Department of Agriculture invites offers to sell canned boned poultry as indicated below and per the Announcement for use in school lunch and other domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Nov. 27. Acceptances will be announced by midnight, Friday, Dec. 1. Deliveries are to be made from Jan. 1 to Jan. 15, 2001.

Offers are invited from the trade for canned boned poultry in 50-ounce (1.42 kg) cans, packed 12 cans to a shipping container. A purchase unit will consist of 1,000 shipping containers totaling 37,500 pounds (17,010 kg).

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.

Delivery by trucks or railcars is optional to the contractor, except for those destination(s) which specify delivery by truck only or rail only.
