CANNED BONED POULTRY, INVITATION NO. 035, ANNOUNCEMENT PY-225, AS AMENDED

The U.S. Department of Agriculture invites offers to sell canned boned poultry as indicated below and per the Announcement for domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Feb. 12. Acceptances will be announced by midnight, Friday, Feb. 16. Deliveries are to be made from April 1 to June 30.

Offers are invited from the trade for canned boned poultry in 29-ounce (822 g) cans, packed 24 cans to a shipping container with 43.5 pounds (19.73 kg) net weight, in purchase units of 36,540 pounds (16,574 kg) net weight.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.
