GRILLED CHICKEN PATTIES, INVITATION NO. 003, ANNOUNCEMENT PY-241--
FINAL REQUIREMENTS

The U.S. Department of Agriculture invites offers to sell grilled chicken patties as indicated below and per the Announcement for school lunch and other domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Dec. 18. Acceptances will be announced by midnight, Friday, Dec. 22. Deliveries are to be made from Feb. 1 to Feb. 15, 2001. Purchase of the quantities listed on this Invitation will complete current requirements.

Offers are invited from the trade for frozen, fully cooked, grilled chicken patties, produced from boneless, skinless thighs (only) and skin, or boneless, skinless thighs and drumsticks and skin. Grilled chicken patties will be packaged 5 or 10 pounds (2.27 or 4.54 kg) per plastic-film bag to a net weight of 30 pounds (13.61 kg) in each fiberboard shipping container. A purchase unit will consist of 1,300 shipping containers totaling 39,000 pounds (17,690 kg).

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.

Delivery by trucks or railcars is optional to the contractor, except for those destination(s) which specify delivery by truck only or rail only.
