TURKEY TACO FILLING, INVITATION NO. 4, ANNOUNCEMENT PY-251

The U.S. Department of Agriculture invites offers to sell frozen cooked turkey taco filling as indicated below and per the Announcement for use in school lunch and other domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Tuesday, Nov. 13 (due to the holiday on Monday for Federal employees). Acceptances will be announced by midnight, Friday, Nov. 16. Deliveries are to be made from Jan. 1 to Jan. 15, 2002.

As stated in the September 21 Notice to the Trade, all offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted on and after October 1, 2001, by any means other than DEBES will be considered nonresponsive.

Offers are invited from the trade for frozen cooked turkey taco filling, produced from ground turkey (ready-to-cook nonbasted, young turkeys or turkey products, and turkey skin), and spices/seasonings. The commodity must be packaged in 3- or 5-pound (1.36- or 2.27-kg) packages to a net weight of 30 pounds (13.61 kg) in each fiberboard shipping container. A purchase unit will consist of 1,300 shipping containers totaling 39,000 pounds (17,690 kg).

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.

Delivery by mechanically refrigerated trucks or railcars is optional to the contractor, except for those destination(s) which specify delivery by truck only or rail only.
