TURKEY TACO FILLING, INVITATION NO. 1, ANNOUNCEMENT PY-256; FINAL REQUIREMENTS

The U.S. Department of Agriculture invites offers to sell frozen cooked turkey taco filling as indicated below and per the Announcement for use in school lunch and other domestic food nutrition assistance programs. Offers from **approved suppliers** are due by 12 noon, Central Time, Monday, March 11. Acceptances will be announced by midnight, Friday, March 15. Deliveries are to be made from April 16 to April 30. **Purchase of the quantities listed on this Invitation will complete current requirements in this test purchase.**

As stated in the September 21 Notice to the Trade, all offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted on and after October 1, 2001, by any means other than DEBES will be considered nonresponsive.

Offers are invited from **suppliers which have been previously approved by the Contracting Officer** for frozen cooked turkey taco filling, produced from ground turkey (ready-to-cook nonbasted, young turkeys or turkey products, and turkey skin), and spices/seasonings. The commodity must be packaged in 3- or 5-pound (1.36- or 2.27-kg) packages to a net weight of 30 pounds (13.61 kg) in each fiberboard shipping container. A purchase unit will consist of 1,300 shipping containers totaling 39,000 pounds (17,690 kg).

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.
