FROZEN COMMERCIAL PACK TURKEY BREASTS, INVITATION NO. 2,
ANNOUNCEMENT PY-281

The U.S. Department of Agriculture invites offers to sell frozen turkey breasts as indicated below and per the Announcement for use in domestic food nutrition assistance programs. Offers are due by 12 noon, Central Time, Monday, Oct. 27. Acceptances will be announced by midnight, Friday, Oct. 31. Deliveries are to be made from Dec. 1 to Dec. 15.

As announced by the Department on Aug. 4, purchases of white meat turkey product will provide assistance to the turkey industry which has faced difficult economic times.

All offers must be submitted electronically through the Domestic Electronic Bid Entry System (DEBES) website at <https://pcsd.usda.gov:3077/mdbc1000.exe?>. Offers submitted by any means other than DEBES will be considered nonresponsive.

Bidders are cautioned to bid only quantities they can reasonably expect to produce and deliver in accordance with the contract. Shipping instructions will indicate quantity to be delivered to each point.

Purchases will be made on a delivered basis, subject to Announcement PY-281, to the listed locations. Destination quantities are estimates and are subject to adjustment based on offerings, changes in recipient need, market conditions, and program operations. Delivery by mechanically refrigerated trucks or railcars is optional to the contractor, except for those destination(s) which specify delivery by truck only or rail only.

Frozen Turkey Breasts, small - Turkey breast breasts must weigh not less than 4 pounds (1.18 kg) and not more than 10 pounds (4.54 kg) each. The difference between individual turkey breast weights per container must be no more than 2 pounds (0.91 kg). The 2-pound (0.91 kg) increments must be: 2-4, 6-9, or 8-10 pounds. (Metric equivalency of increments 1.18-2.72, 2.72-3.63, and 3.63-4.54 kg).
