NATIONAL EGG REVIEW



Prices were unchanged to sharply lower on the larger eggs throughout the week in the Eastern region and Chicago, balance unchanged. Prices elsewhere were unchanged. The market tone was steady to barely steady, with a cautious undertone lingering. Demand was light to good, mostly fair with best movement initiated at retail features. Supplies of jumbo and extra large eggs were generally close with the remainder of the sizes adequate to instances ample. Breaking stock prices were lower for the current week. Supplies were more than adequate from producers, with any trading centering around the heavy nest run product and the availability of graded product. Processors tending to purchase heavy nest run product at the top of the market range. The market undertone was steady at best. Light type hen offerings were fully adequate to ample for processing needs.

THIS COMPARES TO 150.7 MILLION HEAD THE PREVIOUS WEEK AND TO 145.8 MILLION HEAD THE SAME WEEK A YEAR AGO, WHEN THE SLAUGHTER WAS 150.6 MILLION HEAD AND THE 12-CITY WEIGHTED AVERAGE PRICE WAS 70.56 CENTS PER POUND.






New York Large Egg Weekly Average Price, 1997, 1998, 1999
