NATIONAL EGG MARKET AT-A-GLANCE



In New York and Chicago, prices were unchanged. Prices in Philadelphia, Boston, and California were lower on the lighter weight eggs and unchanged on the remainder. Prices in most other areas were lower on all sizes. The market tone was cautiously steady to about steady. Demand was usually moderate and was best where scattered features were in progress for this week. Supplies were adequate to ample. Breaking stock offerings were fully sufficient to ample for the light to moderate demand. Light type fowl were more than adequate for regular slaughter schedules.

NORTH ATLANTIC In Philadelphia and Boston, prices were unchanged to 3 cents lower on mediums and unchanged on the larger sizes, when based on previous week average pricing. In New England, prices were unchanged. The market tone was cautiously steady. Demand into all channels ranged light to mostly moderate. Supplies were adequate to available for trade needs. Breaking stock offerings were fully adequate to ample and demand for additional product was light. Light type hens were more than sufficient for slaughter requirements.

MIDWEST Prices in Detroit and major Ohio and Wisconsin cities were lower for all sizes. Prices to producers in Iowa-Minnesota-Wisconsin were unchanged. Trade sentiment was about steady. Retail and food service demand was usually moderate. Supplies were adequate to ample for all sizes. Central States nest run breaking stock prices were unchanged. Trading and demand light to moderate for the fully adequate to ample offers. Most buyers taking a wait and see attitude and evaluating needs before purchasing additional product. Floor stocks fully adequate to ample. Schedules full-time to over-time. Trade sentiment barely steady to weak.

CHICAGO Prices for all sizes unchanged. The market tone was steady to weak. Retail and food service demand was light to moderate, best where features are planned or in progress. Supplies adequate to available.

SOUTHERN Prices were lower in Atlanta and in Florida. Elsewhere, prices were unchanged. The market tone was about steady with some caution noted entering the week. Demand was light to moderate, best where limited features were in progress for this week. Supplies were adequate to ample for trade needs. The average price on Grade A or better white cartoned large eggs delivered to volume buyers in the Southern region for the week ending September 14, 2001 was 56.82 cents, 3.42 cents less than a week ago and 3.97 cents less than the same week last year. Breaking stock demand was light and supplies were fully adequate to ample. Light type hens were more than sufficient for normal slaughter schedules.

WESTERN Prices throughout the region unchanged on jumbo, extra large, and large, 4 cents lower on medium. The Pacific region inventory was 10% lower than last Monday with California down 4% and regon-Washington-Utah down 18%. Retailer demand light to moderate. Offerings in fair balance.

NEW YORK Prices were unchanged on all sizes. The market tone was cautiously steady. Demand into all outlets was light to mostly moderate. Supplies were adequate to available for trade requirements.
