NATIONAL EGG MARKET AT-A-GLANCE



Prices were unchanged in Chicago and New York. Elsewhere, weekly prices were lower on all sizes. The market tone was unsettled to instances weak. Demand ranged light to fairly good. Supplies were sufficient to at times long for current trade needs. Breaking stock offerings were about adequate to adequate for the moderate demand. Breaking schedules were mostly normal for the post-holiday week. Light type fowl were fully sufficient to ample for the light to fair demand.

MIDWEST REGIONAL Midwest prices were lower for all sizes. All other prices were unchanged. Trade sentiment was steady. Cartoned egg sales were moderate to fairly good for post holiday orders. Food service movement was mostly moderate. Supplies were adequate. Central states breaking stock prices were unchanged. Offerings were adequate for the moderate demand. Most buyers taking a wait and see approach to the market as it settles after the holiday weekend. Floor stocks adequate. Schedules mostly full-time. Trade sentiment steady.
