## NATIONAL EGG MARKET AT-A-GLANCE

In New York, prices were unchanged. Elsewhere, prices were higher on all sizes. Trade sentiment was steady entering the week. Demand into all outlets was light to instances good, best into feature activity planned or in progress. Supplies ranged adequate to fully adequate for immediate trade needs. Breaking stock offerings were adequate for the moderate to good demand. Light type hens were fully adequate for the only fair demand. Slaughter schedules were reported as normal to heavy.

**MIDWEST REGIONAL** Midwest warehouse delivered prices were higher for all sizes. Other reported prices were unchanged. Trade sentiment was steady. Retail demand ranged light to at times fairly good in areas with feature activity. Loose egg sales were mostly moderate. Supplies were in good balance to at times fully adequate. Central states breaking stock prices were unchanged. Offerings were usually adequate for the moderate demand. Regular commitments and existing inventories were enough to satisfy most breaker's current needs. Floor stocks adequate to fully adequate. Schedules full-time. Trade sentiment was steady.

**WESTERN** Prices 4 cents higher on jumbo, extra large, and large; 5 cents higher on medium throughout the region. The Pacific region inventory was 13% higher than last Monday with California up 4% and Oregon-Washington-Utah up 32%. Retailer demand moderate overall, best to planned features. Offerings easily adequate.

**CALIFORNIA** Prices 4 cents higher on jumbo, extra large, and large, 5 cents higher on medium and small. The California inventory was 4% higher than last Monday. Retailer demand moderate, improved where features planned. Offerings adequate. Small benchmark price 58. Ads and prices to consumers in Northern California were not available.
