EXCEPTIONS APPLICABLE: ANY LOT OF AVOCADOS MAY BE HANDLED WITHOUT REGARD TO THE MINIMUM WEIGHT OR DATE REQUIREMENT, IF WHEN MATURE, SUCH FRUIT NORMALLY CHANGES COLOR TO ANY SHADE OF RED OR PURPLE AND ANY PORTION OF THE SKIN OF THE INDIVIDUAL FRUIT HAS CHANGED TO THE NORMAL COLOR FOR THAT FRUIT WHEN MATURE.

THE REQUIREMENTS LISTED IN TABLE 1 OF THIS SECTION ARE IN EFFECT ANNUALLY FROM APRIL 16 THROUGH APRIL 15 OF THE FOLLOWING YEAR, WITH AN EXCEPTION FOR THE REQUIREMENTS FOR THE GUATEMALAN SEEDLING WHICH ARE IN EFFECT ANNUALLY FROM JUNE 9 TO JUNE 8 OF THE FOLLOWING YEAR.
