

Trustee & Contact Information

TRUSTEES: A trustee must be a financially responsible, disinterested person. Trustee's that may be named are CPAs, bank or trust company officials, attorneys-at-law, secretaries or other officers of livestock exchanges or similar organizations, or a State agency or official. Some states **require** you to name a State agency or official as trustee. Please see the next section of this document for a list of those states with that requirement.

The *UNITED STATES DEPARTMENT OF AGRICULTURE, or FTPP, PACKERS AND STOCKYARDS DIVISION*, does not act in the capacity of a Trustee or Obligee. Please do not name them in either position.

STATE TRUSTEES: The following States require you to name a State Agency or Official as trustee on the financial instrument (bond, trust fund agreement (TFA), or trust agreement (TA)). The list includes the type of financial instrument(s) requiring the trustee, and the full name, address, and telephone number of the trustee.
