The U.S. Department of Agriculture (USDA) invites offers to sell frozen pork products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal Food and Nutrition Assistance Programs. Acceptances will be announced by midnight, June 15, 2016. Deliveries are to be made between August 1, 2016 and August 31, 2016.

The pork products are to be delivered fresh chilled or frozen as indicated by product type.

This Solicitation may show multiple stops on some line items; however, the number of stops will be limited to a maximum of three.
