The U.S. Department of Agriculture (USDA) invites offers to sell chicken and chicken products pursuant to the AMS Master Solicitation for use in the National School Lunch Program and other Federal food and nutrition assistance programs. All bulk loads on this Solicitation are No Tolerance. Fewer than 36,000 pounds will be rejected.
